All applications to the First Year Group 2024/2025 in Dunshaughlin Community College will only be accepted after the **16th October 2023** and the closing date for receipt of applications is the **10th November 2023 @ 3pm.** Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy.

All transfer applications for the academic year 2024-2025 to Second, Third, TY, Fifth Year or Sixth Year Group in Dunshaughlin Community College will only be accepted after the **15th April 2024** and the closing date for receipt of applications is the **10th May 2024 @ 3pm.** Applications received after this date will be considered and processed as late applications in accordance with the school's Admission Policy. Please be reminded that, in line with the school's Admission Policy and the Education (Admission to Schools) Act 2018, all waiting lists going forward are only in place for the academic year to which they apply.

All applicants to the First-Year Group 2024/2025 will be notified of an offer of a place or refusal of admission by:	24th November 2023
Successful applicants to the First Year Group 2024/2025 must confirm their acceptance of an offer of admission to Dunshaughlin Community College by completing and returning the Acceptance Form on or before:	15th December 2023 @ 3pm
Note: 1. Failure to accept an offer of admission before the relevant deadline set out above will result in the offer being withdrawn. 2. False & inaccurate information will invalidate the application.
